So You Think You Have FULL COVERAGE? Think Again.

So many times in our practice we talk with new clients about their auto insurance coverage and the clients respond with "I have full coverage". What they don't know is that the term "full coverage" is not what you think it is. Insurance agents are trying hard to get and keep your business by offering you the best price, but sometimes they fail to explain what you are really getting for your money, or in most cases, NOT getting. TYPE	DESCRIPTION	REQUIRED BY LAW?	Typically Included in "Full Coverage"?
Property Damage (PD)	Pays for the damage to someone else's vehicle or property if you cause an accident.	YES – a minimum of \$10,000 coverage is required by law.	YES
Collision/Comprehensive	Pays for the damage to YOUR VEHICLE if the other party does not have insurance or if you cause the accident.	NO, this insurance is not required by law, but may be required by a bank if you have a loan on the vehicle.	YES
Personal Injury Protection (PIP / No Fault Coverage)	Pays for YOUR medical bills and maybe wage loss when in a four wheeled vehicle, regardless of who is at fault for the accident.	YES, a minimum of \$10,000 coverage is required by law.	YES
Bodily Injury Coverage (BI)	Pays for the injuries to someone else's body if you cause an accident.	NO, this insurance coverage is NOT required by FL law.	NO
Uninsured/Underinsured Motorist Coverage **This portion of your auto policy might also cover you if you're on a motorcycle!	Pays for YOUR OWN INJURIES if you are in an accident caused by someone else and they have NO Bodily Injury coverage, or not enough.	NO, this insurance coverage is NOT required by FL law.	NO

We often have clients who are victims of an accident, with severe injuries or even death of a loved one and they believe they have protected themselves with great insurance, "full coverage". Imagine the frustration and resentment they feel when they find out not only did the person that caused their suffering have the minimum required by law, but the client themselves have no Uninsured Motorist Coverage to help pay for their bills, their wage loss, their future.
